## 1. EFP European policy workshop on 'Active and Healthy Ageing- a long term View'

On Monday, 31st January 2011 the first European Foresight Platform (EFP) European Policy Workshop took place in Brussels, focusing on "Active and healthy ageing – a long-term view" in support of the pilot European Innovation Partnership in the field of active and healthy ageing. The workshop participants, among them medical and health experts, industry representatives, researchers and consultants have been working in working groups focussing on the following topics: (1) "Users, products & service design", (2) "Research on Ageing as such", (3) "Work" and (4) "Health Care Delivery".

## 2. Workshop "Technology and Services in the Age of Demographic Change"

A complementary policy workshop at national level will be held in Germany in cooperation with the Institute for social research and social economy (ISO), Saarbrücken. The workshop entitled "**Technology and Services in the Age of Demographic Change**" takes place **March 30**, in **Berlin**. The audience will be comprised of scientists and practitioners from more than 80 research projects whose major focus is to develop new technologies and services supporting the elderly and other physically impaired people to live independently and safe in their own homes. This research cluster is thematically related to the Ambient Assisted Living initiative of the European Commission und supported by the Federal German Ministry for Education and Research. The policy workshop will take an interactive approach for identifying future challenges the German

society is confronted with related to demographic change and future research priorities that arise from these challenges.

A summary of the results from this workshop will soon be presented on the EFP website.

### **5. Yeditepe International Research Conference on Foresight and Futures**

A review of journals in the field(s) of Foresight and Futures Studies point to a tension in the relationship between Foresight and Futures theory and practice. Whether to treat "Foresight studies" and "Futures studies" as two different fields, or to treat them as one field and write "Foresight and Futures Studies" is probably a matter of debate among the researchers. Interested individuals from academic (economics, management, political science, engineering) and business worlds are invited to come together to discuss and communicate on challenging problems related to theory building in Foresight and Future Studies within the historic and mystic environment of

Istanbul. The Yeditepe International Research Conference on Foresight and Futures takes place from **August 24 to 26, 2011**.
